- Interviews against reserved seats for all categories (foreign, pharmaceutical industry, and children of registered pharmacists) shall be held on **Thursday 30th November, 2023.**
- Reporting time for interviews is **8:00 am sharp** at **Shifa College of Pharmaceutical Sciences, 72-Jaffer Khan Jamali Road, Sector H-8/4, Islamabad.**
- Bring all your **original academic documents** (for verification purposes only). This includes Matric/O levels, F.Sc/A levels, equivalence documents (if any), MDCAT result scores, domicile/Birth certificate etc.
- Following verification documents are required for reserved seats:
 - Foreign candidates**, verification against the reserved seat shall be done through their **O/A level certificates** and **equivalency** documents.
 - Nominees of the proprietors, partners and directors of Pharmaceutical Industry** are required to produce **letter of nomination** for verification against the reserved seat.
 - Children of registered pharmacist** are required to bring the **Pharmacy Registration Certificate** of the parent for verification against the reserved seat.
- A briefing for the purpose of **Interview sessions** shall be carried out to give general guidance for appearance in the interviews.
- Any discrepancy found in the data provided by the candidate against the original document shall result in **ineligibility from securing admission at SCPS.**
