

14TH ANNUAL SHIFA SCHOLARS DAY 6th May 2025

EVENT REPORT



Background

Shifa College of Medicine has an illustrious history of providing a platform in form of Annual Shifa Scholars Day; for aspiring researchers to present their work in a collaborative and intellectually stimulating environment. Keeping up with the tradition the 14th Annual Shifa Scholars Day- "From Ideas to Impact: The Power of Research," was held on 6th May 2025 in Shifa College of Medicine.

Introduction

Underscoring Shifa Tameer e Millat University's commitment to academic excellence, research development, and student-led innovation, the Honourable Vice Chancellor Professor Dr. Muhammad Iqbal Khan, Dean Faculty of Health Sciences Professor Dr. Mohammed Amir and Chairperson Professor Dr. Riffat Shafi were instrumental in providing leadership and guidance for the event.

Spearheaded by Professor Dr. Saima Hamid, organizational support was provided by the Department of Community Medicine and Public Health and the student organization READ (Research, Education, Assistance, Development). The event was conducted in a hybrid format, combining both in-person and virtual participation, to facilitate broader accessibility for presenters and observers. This approach allowed students from across Pakistan and international institutions to actively participate regardless of their geographic location, enhancing the diversity and reach of the event.

Call for Abstracts

A call for Abstracts was sent to all PMDC recognized medical and dental colleges in Pakistan. International contributions were also welcomed through Social Media engagement. As a result 243 abstracts from 39 Medical and Dental colleges were received from all over Pakistan along with 3 International submissions

Process for Abstract Finalization

To ensure academic rigor and transparency, the selection of abstracts for the 14th Annual Shifa Scholars Day followed a meticulously structured three-tiered evaluation process:

Level 1: Initial Screening

• A total of 243 abstracts were received.

• The Technical Committee from the Department of Community Medicine and Public Health (CM&PH) conducted the first round of screening to assess basic eligibility, relevance and scientific rigour.

Level 2: Merit-Based Shortlisting

- After initial screening, the selected abstracts underwent cross-evaluation by independent reviewers from faculty of Shifa College of Medicine
- Based on scientific merit, originality, relevance and impact factor, 119 abstracts were shortlisted for the research competition.

Level 3: External Evaluation

- The shortlisted abstracts were further evaluated by a panel of external evaluators, including discipline-specific subject matter experts from Shifa College of Medicine and Shifa International Hospital.
- Following a three-tiered evaluation, 106 abstracts highest standards of academic excellence and discipline were finalized

The abstracts represented four primary research domains:

• Clinical Health Sciences: 66%

Public Health: 19.8%Medical Education: 9.4%

• Basic Health Sciences: 4.7%

The abstracts were categorized as:

Original Research: 51Meta-Analysis: 28Case Reports: 27

This distribution highlights the interdisciplinary focus of the competition and the broad academic interests of participants.

Impact and Outreach

The event featured 99 research presentations. Notably, one international poster from Nepal was also showcased, further enriching the event's global outlook. The competition drew participation of 100 budding researchers and observers from 29 medical and dental colleges across Pakistan reflecting an impressive and diverse national reach.

Suggestions:

- Posters were not arranged in sequence and themes were mixed, making it difficult to evaluate them accurately and making original work receive disproportionately high scores.
- Participation should be limited to original research, as meta-analyses often appear more impressive and may overshadow the efforts and impact of original research studies.

- Each of the three domains had distinct categories with separate winners, so the results remained unaffected.
- To ensure consistency in evaluation, judges should be thoroughly briefed in advance
- Provide judges with tailored rubrics for each research type, emphasizing novelty, methodology, and contribution to knowledge.
